This requires having an unexpired, valid, government-issued photo ID with you at the time of signing. IF YOU ARE UNABLE TO APPEAR IN PERSON AT CONCORDIA UNIVERSITY, YOU WILL NEED TO MAKE ARRANGEMENTS TO SIGN THE VERIFICATION WORKSHEET AND THE APPENDIX A IN FRONT OF A NOTARY OR COMPLETE A VIDEO CALL WITH A FINANCIAL AID ADMINISTRATOR.
- 3. Mail the completed verification worksheet to the Concordia University Financial Aid Office. YOU MUST SUBMIT THE ORIGINAL VERIFICATION WORKSHEET FAXES OR EMAILS WILL NOT BE ACCEPTED.
